Major-Systems Repair Program (MSRP) provides forgivable loan assistance to low- and moderate-income homeowners needing systems rehabilitation to their home. Assistance is an interest-free, forgivable, self-amortizing loan in an amount subject to the City's assessment of needs, not to exceed \$24,000.00.
